Dear colleagues, students and friends of dance at Harvard,

It is with profound gratitude and admiration for her service that we write to announce that Jill Johnson will be stepping down as Senior Lecturer in Theater, Dance & Media and Director of Dance at the end of this academic year. Jill's vision for dance at Harvard has been transformational, and she will be sorely missed. We wish her the very best as she embarks on an exciting series of artistic, educational, and advocacy projects worldwide.

Jill arrived in 2011 as part of an initiative launched by President Drew Gilpin Faust to develop art-making at Harvard. Throughout ten extraordinary years, Jill has been a critical leader who has reinvented the place of dance, movement, and performance at Harvard. She was integral to the design of the concentration in Theater, Dance & Media. In the words of Professor Martin Puchner, who spearheaded the creation of TDM, "Jill is leaving us the gift of an enormous legacy. When we first started to make noises about a new concentration, we only thought about theater. Then Jill came along and taught us to think bigger. It is thanks to her that there is a D in TDM."

The impact that Jill and her team have had on Harvard dance is profound. They have expanded the scope and level of Dance Center offerings across all programs. This includes the creation of eighteen new curricular courses and many more noncurricular courses. The latter are now offered tuition-free to undergraduates.

The Dance Center's annual series of masterclasses and workshops has been equally wide-ranging, embracing practices, traditions, and methodologies that have broadened the community's perspective on dance. Jill also sparked innovative new programs: Emerging Choreographers, a Peer Mentorship Program, and the Harvard Dance Project, to name just a few. Each of these programs fosters the artistic and personal development of Harvard dancers—in many instances, through relationships with world-class teaching artists. All of this was accomplished while guiding and mentoring student-led dance groups involving over 1,000 undergraduates.

Jill has prioritized interdisciplinary inquiry and performance research across a host of fields. Numerous students under her guidance used dance as a form of inquiry to explore conceptual ideas across a range of disciplines. The Dance Center also collaborated with a host of Harvard partners, including the Harvard Choruses,
